1. **Fill out application completely** and submit any “Energy Star” stickers or tags from appliance to application.
2. **Incomplete applications will not be processed.**
3. **Receipts must be type written to be eligible for rebate.**
4. Applicants name must match name on the HUC account to qualify.
5. Rebate offer may be withdrawn or extended at any time without notice at HUC’s discretion.
6. Applications will be processed on a first-come, first-served basis.
7. Installation of all gas appliances must be installed by a Licensed Professional.
8. **Refrigerators and Freezers must show proof of disposal to qualify for rebate.**
9. Installation of item may be inspected by HUC personnel prior to rebate being issued.
10. Determine if a building permit is required before installation.
11. Residential rebates will not exceed a \$500.00 total for each service address.
12. Commercial rebates will be limited to \$2,000 for each service address.
13. Custom rebates are available for larger commercial projects. Contact HUC for verification.
14. **Rebates are limited to specified items only.**
15. Anyone attempting to defraud the HUC Rebate programs will be unable to apply for any future Hutchinson Utilities Commission rebates.
16. Applicants must include an original itemized sales receipt.
