Maximum peak hour demand to date: 65.4 megawatts (MW) on July 31, 2006

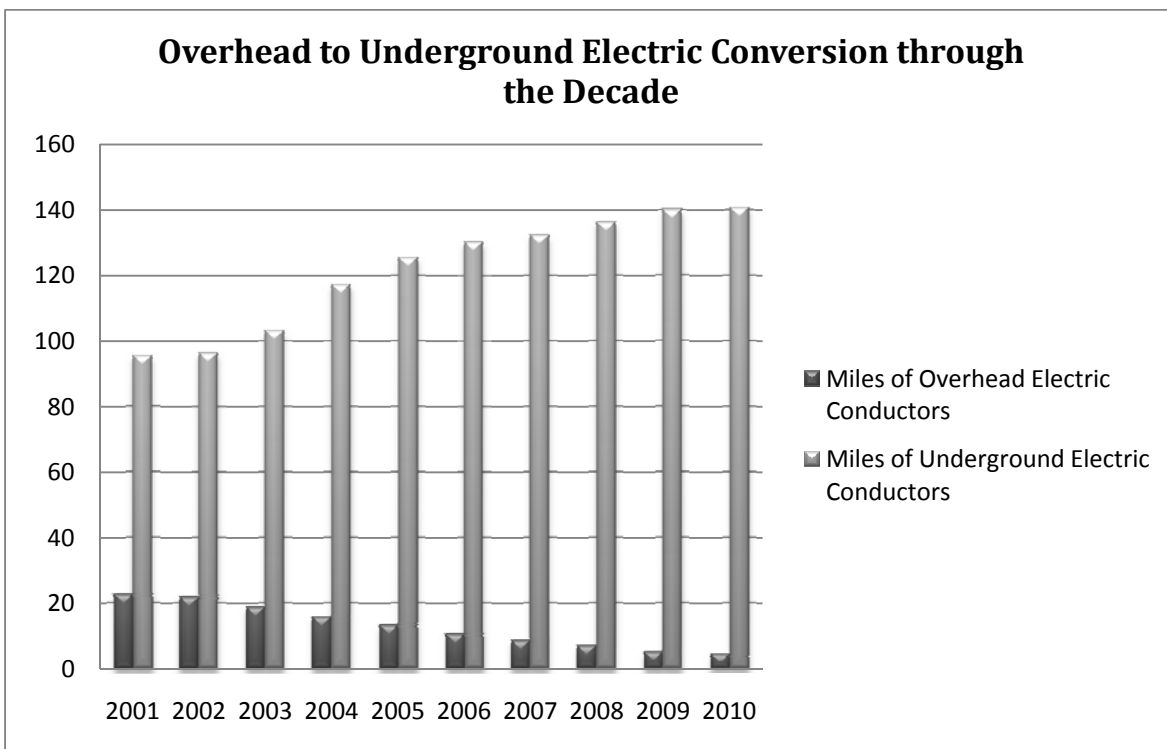
